#### ITEM:

Approval to Purchase Two Semi Tractors for Metro Transfer Stations

#### SUMMARY:

In FY25, \$400,000 is budgeted for the purchase of two truck tractors (semis) at a cost of \$200,000 per truck. The semis are used to haul trash from the transfer stations to the landfill.

#### **DISCUSSION POINTS:**

Metro Waste Authority has a fleet of tractors/trailers to haul trash from transfer stations to the landfill. The equipment is essential to operations, so a regular rotation of replacements is recommended.

#### **STAFF RECOMMENDATION:**

Staff recommends approval to purchase two Peterbilt 567's. Final cost will be under budget at cost of \$199,892 per truck. Staff recommends the Peterbilt due to past experience with others in the fleet and familiarity servicing the trucks.

#### **BUDGET REQUIREMENTS:**

Total cost per truck is \$199,892, which is under budget per semi.

Midwest Peterbilt Group is pleased to present the following bid to Metro Waste Authority for four new Peterbilt model 567 6x4 day cab tractors. Tractors to be the same paint color (Urban Titanium) as previously sold to MWA in 2023. These tractors are presented with four different configurations:

- 430 horsepower 1650 torque Cummins X15 engine with Allison 4500 RDS-P Automatic Transmission
- 430 horsepower 1650 torque Cummins X15 engine with Eaton Endurant XD Pro Automated Transmission
- 430 horsepower 1650 torque PACCAR MX-11 engine with Allison 4500 RDS-P Automatic Transmission (same configuration as the previous 4 567 tractors sold to MWA in 2023)
- 430 horsepower 1650 torque PACCAR MX-11 engine with Eaton Endurant XD Pro Automated Transmission

This bid is presented with these four configurations due to availability and weight factors. The specifications packet provided by MWA indicates that the maximum weight of the tractors shall be 16,000 lbs. The only way to achieve this weight is with the PACCAR MX-11 engine and Eaton Endurant XD Pro Transmission configuration.

Due to Allison's inability to keep up with the demand for their 4000 series transmissions this year it is currently sold out across all manufacturers. At this point it is uncertain what the availability of Allison 4000 series transmissions will look like next year. Earliest availability is currently estimated mid-Q1 and there will likely be an allocated amount of these transmissions for each manufacturer. This creates pricing uncertainty for tractors with the Allison transmission as 2025 pricing has not been released yet. As a result, availability and pricing for tractors with the Allison transmission cannot be guaranteed.

The Eaton Endurant XD Pro is a capable alternative to the Allison with similar performance and functionality while being lighter weight and lower cost. Tractors with this transmission currently have an 8-10 week lead time from the order date.

The following pages contain pricing and weight breakdowns for each of the four configurations as well as a detailed specifications sheet with dimension diagrams.




